DRAFT ORDER

THE FOLLOWING ORDER ISSUES AFTER HAVING CONSIDERED THE MATTERS AND HAVING HEARD COUNSEL ON BEHALF OF THE PARTIES:

- 1. The application under case number 7907/2020 ("the Chapter 5 Application") and the application under case number 46882/2017 ("the Chapter 6 Application") are hereby consolidated and shall henceforth, where required, be subject to case management by Her Ladyship Madam Justice Keightley.
- 2. The application shall be heard and determined in one consolidated hearing, which is hereby set down for 14 September 2020.

- The Provisional Restraint Order granted by this court on 10 March 2020 ("the Provisional Restraint Order") pursuant to the Chapter 5 Application, is hereby extended to 14 September 2020.
- 4. In relation to the Chapter 5 Application, the National Director of Public Prosecutions ("the NDPP"), shall on or before 7 August 2020 file its supplementary affidavit in response to the supplementary affidavit filed by the liquidators on 22 July 2020 ("the Liquidators' Supplementary Affidavit"), which shall be a response confined to only that which is contained in the Liquidators' Supplementary Affidavit.
- 5. In relation to the Chapter 6 Application:
- 5.1. the NDPP shall provide the intervening parties with a complete set of the NDPP's application papers in the Chapter 6 proceedings, by no later than 27 July 2020;
- the intervening parties shall file their answering affidavit in relation to theChapter 6 Application, by 7 August 2020;
- 5.3. the NDPP shall file its replying affidavit in relation to the Chapter 6
 Application, by 25 August 2020.
- 6. The parties shall file any additional and/or supplementary heads of argument in relation to the Chapter 5 and the Chapter 6 Applications by no later than 4 September 2020.
- 7. The liability for costs consequent upon the Chapter 5 and Chapter 6 Applications, to date and including the liability for all wasted costs, are reserved.
