Dear Madam,

YOUR CLIENTS: MINISTER OF HOME AFFAIRS & THE GOVERNMENT PRINTING WORKS & OTHERS: CASE NUMBER: 27628/2021

- 1. We refer to the above matter and your letters dated 19 and 20 May 2022.
- 2. The failure to deal with each and every allegation contained in your letters should not be construed as an admission thereof but rather as a denial.
- 3. We have considered your letters and we hold an instruction to place the following on record:
- 3.1. As communicated to you on numerous occasions your application for leave to appeal against the 1 July 2021 order was filed out of time without a condonation application hence the operation of the court order was not suspended in terms of Section 18 of the Superior Court Act and your clients must fully comply with the court order.
- 3.2. After filing your "condonation application" during November 2021 you did not take any further steps to advance this matter and you only uploaded the application for leave to appeal and condonation application on Caselines after receiving our letter dated 4 May 2022.

- After we launched our urgent contempt application and on 20 May 2022 you requested Judge Mosopa's registrar to furnish you with a date for the hearing of the application for leave to appeal against the 1 July 2021 order and judgment.
- 3.4. On the same day Judge Mosopa's registrar responded as follows to your request for a date:

"Please ensure that there has been compliance with the Judge President's Revised Consolidated Directive. Once I have confirmation hereof from the Appeals Registrar, I will arrange a date for the application to be heard."

- 3.5. Had you complied with the relevant directives, a date for the hearing of the application would have most probably been allocated.
- 3.6. Clearly your clients have not correctly pursued their application for leave to appeal; this flurry of activity appears as if they are merely trying to enrol the application to try and justify their continuous contempt of the court order.

Your letter dated 19 May 2022:

- 4. In your client's opposing affidavit to the main application that was heard during June 2021, it was stated that the server crashed during February 2021, causing the failure to publish gazettes.
- 5. In your letter dated 18 February 2022 you state that the system failure experienced during January / February 2022 was due to a crashed server.

- your letter dated 19 May 2022 you again state that your clients' system challenges with the ICT infrastructure are due to an <u>old and outdated server system</u> which is causing a backlog that can only be processed days later.
- 7. More than a year has passed since the initial crash, yet your clients are still using the outdated server system which caused the initial fiasco; this implies that the root cause of the problem has never been addressed.
- 8. To summarise:
 - 8.1. The Legal Gazette A of 20 May 2022 has not been published;
 - 8.2. The notice to all stakeholders dated 10 May 2022 and your previous letter contains the telephone number of the contact centre. We tried calling the number, but it appears to be out of order.
 - 8.3. The above notice and your previous letter also contain email addresses that we sent emails to and received the following responses, please see attached:

- 9. The similarities of the averments in your letters of 19 May 2022 and 18 February 2022 are disquieting, which merely supports the fact that nothing is really being done by your clients to address the real problem which in turn will ensure compliance with the court order.
- 10. Your offices opposed the urgent application and your clients' opposing affidavit was due to be served <u>yesterday.</u>
- 11. To enable us to properly consider the content of your letter, please furnish us with the following information by close of business today:
 - 11.1. The steps taken by your clients since February 2021 to address the ICT infrastructure problems / failures;
 - 11.2. Details regarding the "two-pronged approach" taken by your clients' technical team and the latest progress report;
 - 11.3. What process our client's members should follow in the meantime as the "interim measures" provided are of no use and are also not working;



- 11.4.\\ The reasons as to why certain gazettes are published weekly and others not (bearing in mind that the same process is followed in respect of the publications of Legal Gazettes A, B and C).
- 12. Our client's rights remain reserved.
- 13. Kindly acknowledge receipt and revert.




