

The plaintiffs replicate as follows to the first and second defendants' plea:

1. **Ad paragraph 1 to 12.2 thereof:**

Save that the plaintiffs note the admissions contained in these paragraphs, the plaintiffs deny the further allegations contained therein as if specifically traversed and put the first and second defendants to the proof thereof.

2. **Ad paragraph 12.3 thereof:**

2.1. It is admitted that the plaintiffs made application to the Western Cape High Court claiming, *inter alia*, a declaratory order that the business model of Mirror Trading International (Pty) Ltd (in liquidation) ("MTI") was illegal and unlawful and that MTI, at all relevant times, operated an illegal and unlawful business.

2.2. The plaintiffs further admit that judgment in the said application has not, as at date hereof, been delivered in the said application.



2.3. Save as aforesaid, the plaintiffs deny the remainder of the allegations in this paragraph as if specifically traversed and the first and second defendants are put to the proof thereof.

3. **Ad paragraph 13 to 16 thereof:**

Save that the plaintiffs note the admissions contained in these paragraphs, the plaintiffs deny the further allegations contained therein as if specifically traversed and put the first and second defendants to the proof thereof.

4. **Ad paragraph 17 thereof:**

4.1. It is admitted that:

4.1.1. The plaintiffs submitted a claim for proof against the insolvent estate of Mr Cornelius Johannes Steynberg;

4.1.2. The said claim was admitted to proof by the presiding officer at a meeting of creditors in the aforesaid insolvent estate; and

4.1.3. The first and second defendants have since made application for the expungement of the claim, which application the plaintiffs opposed, and which application is yet to be decided by the Master as at date hereof.



4.2. Save as aforesaid, the remainder of the allegations contained in this paragraph are denied by the plaintiffs, as if specifically traversed, and the first and second defendants are put to the proof thereof.

5. Ad paragraph 18 to 19 thereof:

Save that the plaintiffs note the admissions contained in these paragraphs, the plaintiffs deny the further allegations contained therein as if specifically traversed and put the first and second defendants to the proof thereof.



**IN RE: INFORMATION REQUIRED IN RESPECT OF DEALINGS BETWEEN  
FXCHOICE AND MIRROR TRADING INTERNATIONAL (PTY) LTD (IN  
PROVISIONAL LIQUIDATION ("MTI") AND RELATED PERSONS / ENTITIES**

1. We refer to the abovementioned matter, as well as the previous correspondence between our offices and yourselves in this regard.
2. We confirm that we represent the provisional joint liquidators of MTI ("our clients").
3. As part of our clients' statutory duty to wind up the affairs of MTI, they are in the process of establishing relevant information pertaining to the business of MTI.
4. In order for our clients to be able to secure relevant information in a format that can be used in further legal proceedings, our clients applied and obtained a court order in the High Court of South Africa, Western Cape Division, Cape Town under High Court case number 935/21 in terms of which an insolvency enquiry has been authorized. In terms of this process, our clients are inter alia entitled to obtain evidence under oath before court appointed commissioners from persons or entities who have access to information relating to the affairs of MTI.

5. The information that you have already provided to the FSCA and to our offices, were of tremendous value and formed the basis upon which the FSCA and our clients were able to show conclusively that Mr Steynberg and MTI were conducting a fraudulent investment scheme.
6. To enable our clients to formally utilize the information provided by you to date, as well as further information as requested below, you are kindly requested to agree to take part in the abovementioned insolvency enquiry, via an online platform on a suitable date and time to be arranged with yourselves for this purpose. These proceedings will be presided over by a court appointed Commissioner in terms of the provisions of Section 417 and 418 of the Companies Act, No 61 of 1973.
7. This process is not aimed at catching you off-guard or ambushing you by confronting you with unexpected questions. It is for this reason that we provide you below with a list of the issues/questions that we want you to cover in your testimony. If any question posed to your representative during the interrogation, requires the matter standing down in order for you to have a proper opportunity to consider same, the undertaking is that such an opportunity will be provided as and when requested.
8. In the premises, you are kindly requested to authorize a representative of FX Choice Limited, with the necessary background and knowledge of the accounts of MTI and Mr Steynberg, to testify under oath via an online platform, as explained above.
9. The specific issues that your representative will be requested to testify to under oath, inter alia include the following:
  - 9.1 A brief description of how Mr Steynberg originally started to do business with FX Choice and a brief description of the history of the business relationship between Mr Steynberg/MTI and FX Choice;
  - 9.2 The issues dealt with in the sworn affidavit deposed to by Mr Daniel Stephenson ("the Stephenson affidavit") dated 28 October 2020, which was

deposited to in response to the questions posed by the FSCA in South Africa. Further questions flowing from the Stephenson affidavit, are dealt with below:

- 9.3 You will also be requested to deal with the information that you provided to us previously in response to our letter to you dated the 1st instant (your written response was dated the 2nd of April 2021) ("the 2nd April 2021 letter"). Further questions flowing from the 2nd April 2021 letter will be dealt with below:

Questions relating to the MAM account referred to in paragraph 3.11 of the Stephenson affidavit and paragraph 7 of the 2 April 2021 letter

- 9.4 A list of all sub-account holders in respect of the MAM account are required;
- 9.5 Copies of the complete trading statements of all sub-accounts connected to the aforesaid MAM account are required;
- 9.6 Who was the trader responsible for trading on the MAM account?
- 9.7 What was the frequency of the trades and is it possible to determine whether or not a BOT or expert advisor was utilized with the Meta Trader 4 software during this phase?
- 9.8 When was the MAM account terminated/closed?

Questions relating to accounts other than the MAM account

- 9.9 In as far as you indicated in the 2 April 2021 letter that MTI had other accounts, i.e. other accounts than account number 174850 with FX Choice, you are requested to please provide us with complete copies of these account statements from inception to closing, alternatively current date.
- 9.10 Please also provide us with copies of all statements in respect of all accounts in the name of Mr Cornelius Johannes Steynberg and Mrs Nerina Steynberg,


from the date of opening of such accounts until current date, alternatively the closing thereof.

- 9.11 Is there any other accounts held with FX Choice in respect of which Mr Steynberg is or was mandated as the authorized individual to exercise control over the accounts? If so, kindly provide us with details of such accounts including copies of all the statements in respect thereof.
- 9.12 With reference to your statement that the last time MTI withdrew funds (paragraph 3.2 of the Stephenson affidavit) was on 1 August 2019, please advise from which account this withdrawal was made, as, according to our records, account number 174850 was only opened/active since 31 January 2020? If account 174850 was opened before this date, kindly provide us with the detailed statements for this account since inception until 31 January 2020.
- 9.13 In as far as it appears from the contents of paragraphs 4 – 6 of the Stephenson Affidavit that correspondence between FX Choice and Mr Steynberg and/or MTI was exchanged, you are kindly requested to provide us with copies of all relevant communication in this regard.
- 9.14 Is it possible from your records to identify the wallet address/origin of all btc and/or fiat currency from which deposits into any of the accounts in the names of either Mr Steynberg, Mrs Steynberg or MTI were made and to which withdrawals were made?
- 9.15 The management of MTI claimed that, after the MAM account was closed, MTI only had one negative day of trading on either the 7th of June or the 7th of July 2020. Please provide us with your comments in respect of this claim.
- 9.16 To your knowledge, is it possible to utilize a bot and/or expert advisor by means of a mobile device?

Dear Clifford Coombe,

Thank you for your letter and please excuse us for not replying sooner. The information you requested has taken some time to collate. We will use your structure to address your queries:

8

Our brand monitoring and marketing departments have brought several media stories to our attention. The huge sums involved in MTI's scheme and the apparently criminal nature of those involved, have our both the Legal department and Senior Management of the company intensely concerned. We feel that involving our colleagues in court proceedings in South Africa could expose them to dangerous criminal elements and jeopardise their safety. We are sure you understand that the safety of our staff is paramount to our company. We therefore are unable to nominate a member of staff to testify under oath. However, we are willing to submit evidence in a text format.

9.1

Cornelius Johannes Steynberg came to FXChoice and registered a profile on 16th February, 2017. He made his first deposit of 290,000 Bits (0.29 BTC) on 25th June, 2018. Mr Steynberg opened 18 (eighteen) Live accounts at FXChoice that had varying degrees of use. We have provided a full list of all accounts in the attachment with their statements. Five of these accounts were opened in 2020. Of these, #174850 was the main account and the other four stood idle (i.e. they were never used). Of the remaining 13 accounts opened prior to 2020, one was the MAM account (Multi-Account Manager account) that Mr Steynberg operated plus three sub accounts (these are attached to MAM accounts). The remaining nine accounts had some activity on them at some point and you can see this in the attached statements. Mr Steynberg's profile had 'personal' status from its initial opening on 16th February 2017 until 16th August 2019 when the account was converted to 'corporate' status. He applied for a corporate account on 5th May 2019, but the paperwork wasn't fully submitted and reviewed until 16th August, which is the reason for the discrepancy.

As well as the 18 Live accounts opened by Mr Steynberg, he also operated three virtual wallets. These operate as non-trading accounts and are designed to hold funds for transfer to trading accounts at opportune moments or for simple replenishment. The wallets he opened were:

1. LTP (Litecoin) wallet #25706 created on 25th June, 2018
2. Bit (Bitcoin) wallet #25707 created on 25th June, 2018
3. USD (United States Dollars) wallet #28793 created on 22nd August, 2018

## 9.6

The trader responsible for trading on a MAM account is the MAM account holder. In this instance, that would be Mr Steynberg. However, we cannot say for certain that it was him who executed all the trades. What we can say is the IP address and device ID that accessed the account. Our records show it was accessed by the MetaTrader 4 app in an iPhone and on two separate MetaTrader 4 applications for Windows PCs. The precise information is as follows:

6ff1c8f4313a42c29437b6a5f30667d1

'140660': login (1180, iphone, dc: 2, cid: 6ff1c8f4313a42c29437b6a5f30667d1)

In the above example, '140660' is the MAM account number, 'iphone' suggests that the client operated on a MetaTrader4 application for iPhone, while '6ff1c8f4313a42c29437b6a5f30667d1' is the unique ID of the MT4 application.

The next two examples show two different MT4 applications that might've been installed on one or different PCs.

## 9.7

We can tell whether a trade was placed manually or by a trading robot (aka 'Expert Advisor' or 'EA'). Mr Steynberg first started trading with an EA on the MAM account, then switching to manual trading. Please see the trading account statement for 140660. We note that Mr Steynberg also made eight manual trades using a mobile phone.

## 9.8.

The last trading order on the MAM account closed on 5th August, 2019. The last login was on 17th December, 2019. The MAM account closed on 19th January, 2020.

## 9.9.

See 9.1. We attached all statements of the 18 accounts connected to Mr Steynberg's profile.

## 9.10.

Mrs Nerina Steynberg opened two Live accounts at FXChoice:

Account #155248 was opened on 25th July 2019 and the last trade was closed on 10th September 2020.

Account #207570 was opened on 30th July 2020 and was never used.

Please refer to the account statement for #155248 for a transactional history.

## 9.11.

There are no other profiles assigned to MTI or either Mr and Mrs Steynberg in our records. However, there are two profiles that belong to senior members of MTI. Both profiles have Sub accounts attached to MTI's MAM account #140660:

Cheri Gray

This client opened the Sub account #144163 on 8th May 2019, which was closed on 19th January 2020 when the MAM account closed.

Clynton Hugh Marks

This client opened the Sub account #143887 on 7th May 2019, and was closed on 25th July 2019.

## 9.12.

The last withdrawal of Bit 165545.00 (0.165545 BTC) was executed on 1st August 2019 from the Bit-denominated wallet #25707.

As explained in 9.1, Mr.Steynberg had several Live trading accounts before opening the MAM account.



**9.13. Correspondence between FXChoice and Steynberg/MTI**

We have a large amount of chat and email correspondence between ourselves and MTI; most of which contains relatively unimportant information. Please could you clarify precisely what correspondence you are looking for? Collecting all correspondence together will take a lot of extra time on our part.

**9.14.**

Please see the attachments (userinstructionList) where we detail all transactions conducted by Mr and Mrs Steynberg. Please remember that the transactions are denominated in Bits. There are 1,000,000 Bits in one BTC (Bitcoin).

**9.15.**

MTI claim to have had 'only one negative trading day', but our records show that to be far from the truth. The trading statement for account #174850 details MTI's heavy losses.

**9.16.**

To the best of our knowledge, it isn't possible to run an EA on a mobile platform. The PC version of the MT4 trading platform is required to run an EA.

If the video shows the account number and/or any trade number, we'll be able to determine whether it was a Live or Demo account. The video provided to 'crypto analyzer' on YouTube, as we mentioned in our previous correspondence, was clearly doctored as it showed an order number that belonged to a Demo account whilst clearly showing the trading was being conducted using a Live account. The two pieces of information on that video are mutually exclusive and cannot be on the same screen at the same time.

Thank you for itemising your request. We will respond in kind.

1. The trader responsible for trading on a MAM account is the MAM account holder. In this instance, that would be Cornelius Johannes Steynberg. However, we cannot say for certain that it was him who executed all the trades.
2. We have attached all of the account statements for Cornelius Johannes Steynberg. These include the periods he traded with us an individual and under MTI.
3. The account statements we have attached detail all of the accounts Cornelius Johannes Steynberg opened and controlled at FXChoice. We have no way of knowing whether he was given control of other accounts.
4. All deposits and withdrawals were made in BTC (bitcoin). We have attached a file (mti\_instr.xlsx) detailing all of Cornelius Johannes Steynberg's deposits and withdrawals.
5. We have attached the statement for account 174850 – this is the main account used by MTI and the transfers to the liquidators were made from it. We confirm that this account was opened by Cornelius Johannes Steynberg and was transferred to MTI upon requesting corporate status.
6. This is not a wallet, but an account. Its statement is also attached. As you can see, the last operation took place on 02.05.2019.
